ORDER



AND WHEREAS, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2015-2016 vide ERC's No. 31823 dated 22.05.2015 as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

3. AND WHEREAS, the institution has submitted representation vide letter dated 09.12.2019 received in this office on 19.12.2019, wherein requested to reduce the intake from 100 unit (two units) to 50 intake (one unit) of B.Ed. course.

4. AND WHEREAS, the ERC in its 278th meeting held on 16th – 18th January, 2020 considered the request along with original file of the institution and other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and decided as under:-

As per the request by the institution dated 09.12.2019 for reduction of 01 unit of B.Ed. (50 intake) from 100 intake is permitted with immediate effect.




